NATIONAL AND INTERNATIONAL RESTRICTED TENDER NOTICE N°16/2009

This notice to tender is addressed to companies or group of companies qualified in public works as main activity and being classified in **the category eight(08) and more** for the national companies and the **equivalent category for the foreign companies**.

The works public direction of Illizi launches a national and international restricted tender for the realisation of the project: **Works of Backing Of ILLIZI airfield**.

The relative fold to this tender is withdrawn from the Direction of **Public Works of Illizi wilaya**.

The technical and financial bids will be composed each of the following pieces:

1 - technical bid:

1	The declaration to subscribe, duly full and signed by the habilitate(s) person (s)
2	Instruction to tenderers, duly signed and initialed.
3	bail of submission (Original) >1% should be presented in a closed and sealed envelope
4	Special Prescription notebook signed and initialed without indicating the amount
5	Legalised copy of the certificate of qualification and professional classification main activity in public works, category eight (08) and more in current validity for national companies and the equivalent category for foreign companies.
6	Legalised copy of Fiscal and par fiscal documents in current validity (under 03 months) for the national and international tenders having worked in Algeria
7	Legalised copy of the extract of role balanced
8	Legalised copy of by the fiscal services, certified by commissioner to accounts , aimed by the fiscal services, of the three (03) last years.
9	Legalised copy of the trade register.
10	Legalised copy of noted statute of the company.
11	Legalised copy of the fiscal matriculate card
12	Extracted of the criminal record of the signatory of the submission.
13	Material means list put in the disposition of the project with property justifications or contracts of renting.
14	list of the framing to put in the disposition of the project, justified with diplomas and CVs
15	Professional references of the company justified by attestations.
16	Estimated Planning of works execution
17	Contract of companies group where the chief of the tread must be majority of 51 % . category eight(08) and more minimum five(05) .

NB : for foreign companies, fiscal and parafiscal pieces must be legalised by services of consulate.

2 - Financial bid:

Piece number	designation of pieces
1	Letter of submission, duly full dated and signed.
2	Prices unit slip, duly full, dated and signed.
3	Quantitative and approximate estimates, Duly full dated and signed.
4	Under detail of unit price, dated and signed.

The technical bid: put in a closed envelope carrying the following mention: « **name and address of tenderer – national and international restricted notice for : Works of Backing Of ILLIZI airfield – technical bid**».

The financial bid: put in an envelope closed carrying the following mention: - « **name and address of tenderer – national and international restricted notice for : Works of Backing Of ILLIZI airfield –financial bid**».

bail of submission put in an envelope closed

The three indicated envelopes must be put in a double envelopes **closed, polished and anonymous** and carrying the following mention: « **Avis d'appel d'offres national et international restreint - Travaux de Renforcement De l'Aérodrome d' ILLIZI** ».

They must be sent or deposited to the Public Works Direction of Illizi wilaya

- The date limits deposit of offers is fixed to thirty **sixty (60)** from the first date of release of the tender in the BOMOP or national daily newspapers.

- All offers that will arrive the after noon (12H00Mns) of the last opened day to deposit will not be received by the contracting service.

- Tenderers will remain committed by their offers during a length of hundred-eighty **(180) days** from the deposit date limit of offers.

NB: the opening of technical offer folds is public and will take place the last opened day corresponding to the deposit date limits of the bids at thirteen (13) o'clock in the seat of the Public Works Direction of the Illizi wilaya (in a case where this day coincides with a weekend or a holiday day, the opening of folds will take place the following day at thirteen (13) o'clock)
